Please be kindly informed that due to the introduction of ISPS in the container relevant port areas of Norrköping as well as a 2,5% increase of cargo dues, a new cost structure will apply as from 01. March 2010.

Therefore please note that the THC will be amended as follows:

20 FT laden containers	380 SEK
40 FT laden containers	453 SEK

for containers being moved through the port of Norrköping as from 01. March 2010.

The THC for empty container remains unchanged:

20 FT empty containers	178 SEK
40 FT empty containers	215 SEK
