As a means of securing a reliable schedule on the main corridors between Hamburg and Poland as well as on Rotterdam and Gdynia /Gdansk, we decided to suspend POL 1 service and adjust our current POL 2 and POL 3 setup.

- **POL 1:**
  - Termination with arrival of M/V El Toro eta Hamburg 04.05.2010
- **POL 2:**
  - Bremerhaven – Hamburg – Gdynia – Gdansk – Szczecin – Bremerhaven
  - M/V El Toro ets Hamburg 07.05.2010, ets Bremerhaven 08.05.2010
- **POL 3:**
  - Rotterdam – Hamburg – Gdynia – Gdansk – Rotterdam
  - M/V El Temerario ets Rotterdam 02.05.2010, ets Hamburg 04/05.05.2010
